'Dhaka temple guarded by Hindus and Muslims'

Describing the deity of the ancient Dhakeswari Temple here as a "mother to all humans", a priest of the revered shrine said several Hindus, Muslims and others from the local community had

come together to guard it soon after the fall of the Sheikh Hasina government in Bangladesh.

Dhakeswari National Temple, one of the prominent 'shakti peethas'. "People of many religions come here to pray. And, Maa (Goddess) is mother to all humans whether it is Hindus, Muslims, Christians or Buddhists. They come here to seek solace, prosperity and mental peace."

After serving the temple for 15 years, he looks at the shrine of 'Maa Dhakeswari' as a symbol of religious and communal harmony. The 53-year-old priest says the evening aarti at the temple is performed at 7 pm, nearly 30 minutes after the Maghrib prayer at mosques nearby.

Hasina left the country, "no visitor was here", he said, adding there was "no police force" either at that time as everything was in disarray amid political chaos.
